<p><b><u>DUTIES AND RESPONSIBILITIES:</u></b></p> <p>Under the direct supervision of the Officer-in-Charge, National ICT Planning Development Division (NIPDD), the PLO III in a job order basis, shall be tasked to perform the following:</p> <ul style="list-style-type: none"> <li>● Develop a work plan for the division regarding the formulation of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan;</li> <li>● Undertake table research and conduct round table discussions, researches and surveys, focus group discussions (FGDs) and meetings relevant to the formulation of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan in consideration of existing national policy frameworks for ICT sector (e.g. PDS, PDP, etc.) and international best practices as reference documents, and understanding of key areas of concerns, such as national development goals, ICT laws, policies, rules and regulations;</li> <li>● Prepare, synthesize and package papers on policy, technical and economic issues that may develop or occur within the period of the contract for consideration in the timely formulation of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan;</li> <li>● Identify, develop, and review policies and standards which may be of significance in enriching the elements, trends, and thrusts for the overall achievement of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan mission and vision;</li> <li>● Conceptualize workshop design and program of activities of promotion and advocacy activities of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan and of other related activities in the implementation of the plans that may be required from time to time;</li> <li>● Closely collaborate with the lead researchers for the formulation of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan related activities such as baseline analysis and targeting, documentation of consultations held, etc.;</li> <li>● Monitor and evaluate the results of activities using the performance measurement framework for the formulation of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan;</li> <li>● Lead in the conduct of activities relevant to the formulation of Strategic ICT Roadmap and the Digital Infrastructure Plan for LGUs and oversee the coordination in the eliciting of support from other DICT Offices/Bureaus/Services/Divisions;</li> <li>● Act as technical backstop to NPCMB Director, NIPDD Chief and Senior Staff in various activities related to the formulation of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan;</li> <li>● Perform any other tasks deemed necessary to achieve the objectives of Strategic ICT Roadmap for LGUs and the Digital Infrastructure Plan in accordance to the instruction of NPCMB Director, NIPDD Chief and Senior Staff;</li> <li>● Provide substantial support on the implementation of Digital Terrestrial Television Broadcasting (DTTB) Migration Plan Communication Strategies;</li> </ul>		

- Provide substantial support in the conceptualization and conduct of activities related to the development and implementation of various ICT plans and frameworks such as the E-Government Masterplan 2022, NICTEF, and the Digital Innovation Ecosystem Profile; and
- Comply with the policies, code of conduct, and other applicable rules and regulations.
